- Farmer Organizations/Associations/Networks
- NGOs
- Academic and Research Organizations
- Faith-Based Organizations
- Community-Based Organizations
- Labour Unions
- Media
- Youth Organizations
- Women's Organizations

The CNC aims to realize CAADP by:

- Informing and advocating for inclusive policies
- Supporting and implementing relevant programs and initiatives to deliver results
- Creating awareness of national, regional, and continental level policies and resources
